The City of West Park will receive sealed proposals until **3:00 P.M. local time, Tuesday, April 09, 2024** at the City Clerk's Office, City of West Park, City Hall, 1965 South State Road 7, West Park, Florida 33023, for the following project:

Citywide Sidewalk Restoration and ADA Compliance – Phase 2

Scope of Work

The work consists of restoration of damaged or deteriorated concrete sidewalk along with ADA intersection ramp upgrades and associated tree root barrier and swale restoration (where applicable) along the following roadways:

SW 22nd Street

SW 23rd Street

SW 24th Street

SW 54th Avenue from SW 36th Street to SW 38th Court

Bids will be opened publicly at or shortly after 3:05 P.M. on **Tuesday, April 09, 2024** at the City of West Park, City Hall, City Commission Chamber, located at 1965 South State Road 7, West Park, Florida 33023.

Bid documents may be obtained on or after **March 10, 2024**. Bid documents are available for electronic download from Demandstar at <http://www.demandstar.com> and from the City's website at: www.cityofwestpark.org.

The bid will be awarded to the lowest responsible responsive bidder. If, however, the City Manager deems it to be in the best interest of the City of West Park, the City Manager reserves the right to reject any and all bids, to waive any informalities or minor defects in any bids, and to increase or decrease the quantities shown in the Bid Form. Bids, which contain irregularities of any kind, may be rejected as informal.

This project is being funded in part by the Broward County CDBG. All HUD Federal Rules and regulations pertaining to this project are applicable. Federal Davis-Bacon wage rates for classifications are specified and must be complied with. Fringe benefits must be added to the prevailing hourly wage where applicable. Section 3 of the Housing and Urban Development Act of 1968 which requires that economic opportunities to the greatest extent feasible be given to low and very low income persons and to businesses that provide economic opportunities to these persons. Any organization which is debarred or suspended or is otherwise excluded from or ineligible for participation in Federal assistance programs under Executive Order 12549,

"Debarment and Suspension" will be considered ineligible for contract award.

A mandatory pre-bid conference will be held at the City of West Park City Hall located at 1965 South State Road 7, West Park, Florida 33023, at **1:00 pm** on **Tuesday, April 2, 2024**. All interested contractors are invited to attend.

The City of West Park is an Equal Opportunity Employer and encourages the participation of certified Black MBE contractors.

Where applicable, the City's Local Preference Policy (as outlined in the City's Code Section 2-164), will be considered when evaluating proposals and awarding services. If the local company is a subcontractor, the proposer must delineate the specific elements of the work the local company will perform and the dollar value of the work as a percentage of the total contract value. This documentation must be signed by both the proposer and local company to confirm their intent to establish a business relationship and confirm the local company's percentage.
