



ADDENDUM NO. 1

TO REQUEST FOR PROPOSALS (RFP # 25-0501) RESIDENTIAL SOLID WASTE, BULK WASTE, AND RECYCLING COLLECTION SERVICES

TO ALL APPLICANTS:

The following changes are issued to add to, modify and/or clarify the referenced **RFP # 25-0501** document:

1. **Section 3.5: Interpretations and Inquiries** – The deadline to submit questions shall be revised to no later than **11:00 am, local time, on Thursday, April 17, 2025**.
2. **Section 4.10: Estimated Schedule** – The Last Date for Submittal of Written Questions shall be **11:00 am, local time, on Thursday, April 17, 2025**.

4. **Page 67, Section 6 – Cost Forms – Form 2: Residential Curbside Cart Collection Services (Revised form is attached)**
 - First paragraph shall be revised as follows: “Collection service rates proposed on this form shall be fixed for the first five (5) years following execution of the Agreement, through December 31, 2030 and shall reflect service requirements as specified in the Agreement.”
 - The amount reflected in item 4 Disposal Rate shall be replaced with “*” and the footnote “(B)” shall read: “This amount shall be County’s fixed rate as adjusted from time to time.”
5. **Page 68, Section 6 – Cost Forms – Form 3: Residential Curbside Automated Cart Collection Services (Revised form is attached)**
 - First paragraph shall be revised as follows: “Collection service rates proposed on this form shall be fixed for the first five (5) years following execution of the Agreement, through December 31, 2030 and shall reflect service requirements as specified in the Agreement.”
 - The amount reflected in item 4 Disposal Rate shall be replaced with “*” and the footnote “(B)” shall read: “This amount shall be County’s fixed rate as adjusted from time to time.”

These changes shall have full force and effect. All applicants shall incorporate this addendum into the Bid Documents and shall acknowledge receipt of this addendum on the Bid Document.
