**TO ALL APPLICANTS:**

The following changes are issued to add to, modify and/or clarify the referenced **RFP # 20-0911** document:

1. **Page 10. Section 2.4.4 – Additional Services – Table 2.4.4.1**  
See revised table attached.
2. **Page 34. Section 4.5 – Qualification Evaluation**  
Final sentence (“Any Proposer found non-responsive and/or not meeting qualifications shall have their Cost Packages returned unopened”) shall be struck through.
3. **Page 34. Section 4.6 – Cost Package**  
Shall be revised as follows: “Proposals that are received by the deadline, shall have their Cost Packages opened publicly via live stream platform.”
4. **Page 49. Section 5 – Form 9: Performance Bond**  
Shall be revised as follows: “Amount – 110% of the cost of providing the service for the highest annual price, or \$2 million, whichever is greater.”
5. **Page 67. Section 6 – Cost Forms – Form 2: Residential Curbside Cart Collection Services**  
First paragraph shall be revised as follows: “Collection service rates proposed on this form shall be fixed for the first three (3) years following execution of the Agreement, through December 31, **2023** and shall reflect service requirements as specified in the Agreement.”
6. **Page 68. Section 6 – Cost Forms – Form 3: Residential Curbside Automated Cart Collection Services**  
First paragraph shall be revised as follows: “Collection service rates proposed on this form shall be fixed for the first three (3) years following execution of the Agreement, through December 31, **2023** and shall reflect service requirements as specified in the Agreement.”
7. **Page 75. Section 7 – Agreement – Appendix B-1**  
Appendix B-1 shall be deleted.

These changes shall have full force and effect. All applicants shall incorporate this addendum into the Bid Documents and shall acknowledge receipt of this addendum on the Bid Document.
