SW 25 STREET COMPLETE STREET IMPROVEMENT**

The City of West Park will receive sealed proposals until **3:00 P.M. local time, on Friday, February 18, 2022** at the City Clerk's office, City of West Park, City Hall, 1965 South State Road 7, West Park, Florida 33023, for the following project:

SW 25th STREET COMPLETE STREET IMPROVEMENT

The City of West Park has identified the need to construct a complete street improvement along the corridor of SW 25th Street, from State Road 7 (to the West) to SW 40th Avenue (to the East). The project requires the Contractor to provide full construction services. The Contractor shall be responsible for furnishing all labor, materials, supplies, and equipment to construct the complete street project. Project elements include clearing/grubbing, concrete sidewalks, sodding, pavement milling and resurfacing, grading, drainage, signing and pavement marking in accordance with contract plans prepared by R.J. Behar & Company, Inc.

Bids will be opened publicly at or shortly after 3:05P.M. on **February 18, 2022** at the City of West Park City Hall, City Commission Chambers, located at 1965 South State Road 7, West Park, Florida 33023.

Bid documents may be obtained on or after **January 20, 2022**. Bid documents are available for electronic download from Demand Star at <http://www.demandstar.com> and from the City's website at: www.cityofwestpark.org.

The bid will be awarded to the lowest responsible responsive bidder. If, however, the City Manager deems it to be in the best interest of the City of West Park, the City Manager reserves the right to reject any and all bids, to waive any informalities or minor defects in any bids, and to increase or decrease the quantities shown in the Bid Form. Bids, which contain irregularities of any kind, may be rejected as informal. All bidders must be authorized to transact business by the State of Florida and must be enrolled in the E-Verify system to confirm the eligibility of all new employees.

This is a Surtax funded Municipal Transportation Project. Funding will also be provided by the American Rescue Plan Act (ARPA). All Federal Rules and regulations pertaining to this program are applicable. Federal Davis-Bacon wage rates for classifications are specified and must be complied with. Fringe benefits must be added to the prevailing hourly wage where applicable. Any organization which is debarred or suspended or is otherwise excluded from or ineligible for participation in Federal assistance programs under Executive Order 12549, "Debarment and Suspension" will be considered ineligible for contract award.

A non-mandatory pre-bid conference will be held through video conferencing using the Zoom platform at **10:00 am** local time on **Thursday, February 03, 2022**. All interested contractors are invited to attend. The Zoom meeting may be accessed as shown below.
